- 12.1 a) To approve the installation of 1 no. 360° camera and 2 no. fixed cameras in Bedlington Station at a cost of £3224 per annum plus one off installation costs of £192.
b) To fund full first year costs including installation to be funded from balances and thereafter subject to satisfactory evaluation, budget provision to be established for future years.
- 12.2 To approve 4 weeks detached youth work / youth consultation during March 2022 at a cost of £850 to be met from existing youth budget.
- 12.3 a) To approve the purchase of 1 no. 20' storage container at a cost of £3750 plus VAT.
b) To agree to fund the purchase the storage container from free reserves.
- 12.4 That the Council approves the recommendation of the Services Working Group, that in the case of white concrete asbestos removal:
a) the Parish Council will provide plastic sheeting and adhesive tape to secure the waste.
b) the cost of removal of the waste shall be borne by the relevant plot holder.
c) that such policy shall be incorporated into the Hazardous substances 'and materials' section of the Allotment policy and into the Tenants rules and responsibilities.
